

2020 - 2021 Verification Worksheet Dependent Student

Your 2020–2021 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law states that before awarding any Federal Student Aid, we must ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information, the financial aid office will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information will be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and the other required documents to the financial aid office at Green Hall 101. If you have questions about this form, contact the financial aid office as soon as possible at (609) 771-2211 so that your financial aid will not be delayed.

B. Family Information

C. Dependent Student's Income Information to Be Verified

1. <u>TAX RETURN FILERS</u>— complete this section if the student filed or will file a 2018 income tax return with the IRS. <u>If no</u> return was filed, skip to question #2.

Check the box that applies:

The student <u>has used/will use</u> the IRS Data Retrieval Tool in FAFSA on the Web to retrieve and transfer 2018 IRS income information into the student's FAFSA, either on the initial FAFSA or when making a correction to the FAFSA. *TCNJ will use the IRS information transferred into the student's FAFSA to complete the income verification process*.

The student is <u>unable or chooses not to</u> use the IRS Data Retrieval Tool in FAFSA on the Web, and the student will submit to the school, if required, a **2018 IRS tax return transcript or a photocopy of the "home" income tax return**. To obtain an IRS tax return transcript, go to <u>www.IRS.gov</u> and under "Tools" click on the "Get a tax transcript" link, or call 1-800-908-9946. Make sure to request the "IRS tax return transcript" and not the "IRS tax account transcript." You will need your Social Security Number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed). It takes up to two weeks for IRS income information to be available for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers.

It takes up to two weeks for IRS income information to be available for the IRS Data Retrieval Tool for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers.

2. <u>TAX RETURN NONFILERS</u>— complete this section if the student <u>will not file and is not required to file a 2018</u> income tax return with the IRS.

Check the box that applies:

The student was not employed and had no income earned from work in 2018. Proceed to Section D.

1. <u>TAX RETURN FILERS</u>— complete this section if the student's parent(s) <u>filed or will file</u> a 2018 income tax return with the IRS. If no return was filed, skip to question #2.

Check the box that applies:

The student's parent <u>has used/will use</u> the IRS Data Retrieval Tool in FAFSA on the Web to transfer 2018 IRS income information into the student's FAFSA, either on the initial FAFSA or when making a correction to the FAFSA. *TCNJ will use the IRS information transferred into the student's FAFSA to complete the income verification process*.

The parent will need his or her Social Security Number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2018 IRS tax return was filed). It takes up to two weeks for IRS income information to be available for electronic IRS tax return filers, and up to eight weeks for paper tax return filers. If the parents are married, and separate 2018 tax returns were filed, 2018 IRS tax return transcripts must be submitted for each parent.
