# The Garden State Guarantee GSG

Begins Fall of 2022 for the 2022-2023 academic year

## GSG – THE BASICS

- Provides up to four semesters of free or reduced <u>tuition</u> and <u>mandatory</u> fees.
- Students whose family's Adjusted Gross Income is \$0-\$65,000 annually may be eligible for free tuition and mandatory fees.
- Students whose family's Adjusted Gross Income is \$65,001–\$80,000 annually may be eligible to receive assistance such that their net cost for tuition and mandatory fees is no more than \$7,500 per year.
- Is a "last dollar" award therefore, all federal, state, institutional, and private grants/scholarships must be awarded first.
- The Adjusted Gross Income is based on what is reported on the FAFSA but only those who filed or will file a tax return will be considered.
- Families with a negative Adjusted Gross Income are not eligible for the program.


## GSG - THE BASICS...continued

- Students must be enrolled full time without exception.
- The third year at The College of New Jersey is defined as having earned 15—22 units.
- The fourth year at The College of New Jersey is defined as having earned 23—32 units.
- Students may receive a maximum of four semesters of funding.
- Students must be making Satisfactory Academic Progress.
- Students must be working toward their first bachelor's degree.
- No appeals to the GSG eligibility criteria can be considered

## GSG – WHAT DO I NEED TO DO TO BE CONSIDERED

- If TAG received in the prior academic year:
  - Complete your Free Application for Federal Student Aid (FAFSA) by APRIL 15, 2022.
- If NO TAG received in the prior academic year:
  - Complete your Free Application for Federal Student Aid (FAFSA) by SEPTEMBER 15, 2022.
- Provide any additional documentation requested by The College of New Jersey Office of Financial Aid or by the New Jersey Higher Education Student Assistance Authority.
- Student must have a complete TAG record with HESAA

- OSFA will review the student's 2022-2023 tuition and mandatory fees.
  - Mandatory fees are as follows:
    - General Service/Capital
    - Student Activity
    - Student Center
    - \*GSG does not cover Card Service or any other fees/expenses



- OSFA will review the financial aid awarded
  - Since this is a last dollar program all grants and scholarships (free money) from federal, State, institutional and private sources must be applied first. Students who have any remaining need after those awards are applied will be considered for GSG.



- After tuition and fees are calculated and all Grants & Scholarships (Grants/Sch.) are awarded, OSFA will review if the student meets the income guidelines and apply the appropriate formula.
- \$0 \$65,000 income:
  - Tuition/Fees Grants/Sch. = GSG
- \$65,001 \$80,000 income:
  - Tuition/Fees Grants/Sch. \$7,500 (Student Contribution SC) =
- \$80,001 and above: Not eligible

Until the College's PAWS system reflects the correct number of transfer credits/Units we will not be able to determine GSG eligibility.
