

## 2018 - 2019 Non-Tax Filing Statement INDEPENDENT STUDENT/SPOUSE

Your Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. Please note: You are being asked to complete this form because YOU, the student, and/or your Spouse (if applicable) indicated on the FAFSA that you did not file a 2016 US income tax return and had no earned income. The US Department of Education requires that we confirm this information.

In addition to completing this form, YOU and/or your Spouse (if applicable) must request a Verification of Non-filing statement from the IRS and submit it along with this form.
