Please note: You are being asked to complete this form because YOU, the student, and/or your Spouse (if applicable) indicated on the FAFSA that you did not file a 2018 US income tax return and had no earned income. The US Department of Education requires that we confirm this information.

In addition to completing this form, YOU and/or your Spouse (if applicable) must request a Verification of Non-filing statement from the IRS and submit it along with this form.
